

2023 RULES & REGULATIONS

- 1. Games Across Acadiana is a raffle organized by and benefiting Miles Perret Cancer Services (MPCS).
- 2. Entries may either be purchased for \$20 each at shopmilesperret.com or "earned" by participating in Acadiana's Ultimate Scavenger Hunt. All entries, regardless of how acquired, will be placed together in the same hopper. No distinction will be made as to how the entries are acquired; all entries will have equal chance at winning.
- 3. All teams participating in the scavenger hunt are required to complete the Mission entitled "Who's the Captain?" wherein they identify the Team Captain. This is applicable even for solo teams (teams with only one member). The answers will be visible to MPCS and your teammates only. The answer will NOT be visible to all other participants in the activity feed. Entries earned through the scavenger hunt are assigned to the Team Captain; individual team members do not get entries. It is the sole responsibility of the Team Captain to allocate any prize won among the team members. Failure to complete the "Who's the Captain?" mission may result in forfeiting any prize won. When selecting a Team Captain remember that he/she must have a picture ID in that name. Also remember that while all ages are encouraged to play, you must be at least 18 years old to claim a prize. If the winner is under the age of 18, a parent or guardian may claim the prize on their behalf.
- 4. All sales of raffle entries will be final; there will be no refunds. The entry will be revoked if issued in exchange for a check returned for "insufficient funds" or for a credit card deemed "declined," "invalid," or "stolen."
- 5. A random prize drawing will be held on Saturday, June 24, 2023. It will be broadcast live on the MPCS Facebook page, beginning at 10:00am (CST). You need not be present to win.
- 6. Prize Drawing

Fifty-one (51) prizes will be awarded. Each prize is valued at over \$50.

Prizes include:

Grand Prize - \$10,000 18 tech/electronics prizes Gift cards from local businesses and restaurants

A full lising of prizes will be available on the MPCS website.

All winning tickets associated with the first 50 prizes awarded will be placed back into the hopper for the drawing for the Grand Prize.

7. Winners will be contacted via phone, mail, email and/or the app. Prizes must be picked up at MPCS office (2130 Kaliste Saloom Road, Suite 200, Lafayette, Louisiana) by July 31, 2023. A complete listing of prize winners will be posted to the MPCS website and Facebook page. You must be at least18 years old to claim a prize. If the winner is under the age of 18, a parent or guardian may claim the prize on their behalf.

- 8. If a winner does not claim his/her prize by July 31, 2023, or if MPCS is unable contact a winner due to insufficient, inaccurate, or illegible contact information, or if the winner is deemed ineligible to win a prize, MPCS will select a substitute winner by random drawing from the remaining eligible entry tickets. All prizes will be awarded.
- No cash equivalent prizes or exchanges will be provided in lieu of the designated prizes. Winners must accept
 prizes "AS IS" without alterations or additions and with absolutely no express or implied warranties of any
 kind.
- 10. Any taxes and fees are the responsibility of the winners. The IRS requires that taxes on prizes greater than \$5,000 must be paid upon acceptance and before MPCS may deliver the prize to the winner. With respect to purchased entries, the IRS has adopted the position that the \$20 ticket price is not deductible as a charitable donation for Federal Income Tax purposes.
- 11. By playing the game or purchasing an entry, the players/entrants release MPCS, its officers, directors, agents, volunteers, staff, sponsors, and other related entities from any and all claims, demands, actions, liabilities, losses, costs, expenses, including without limitation attorneys' fees, arising out of his/her participation in the game play, the raffle and/or acceptance/use of a prize.
- 12. MPCS Board Members and MPCS employees are not eligible to win a prize.
- 13. MPCS reserves the right to postpone the event due to Acts of God or other circumstances beyond its control.
- 14. MPCS reserves the right to delete any submission it deems inappropriate; the associated points will be deducted. Additionally, the team submitting the inappropriate video, photo, or text may be disqualified from further participation in the game. Teams with inappropriate team names may be required to change their name or be disqualified from the game.
- 15. All decisions and interpretations of these rules and regulations will be made by the Games Across Acadiana Committee and its judgement(s) will be final.
- 16. MPCS Game procedures, ticket issuance, and prize drawing will be audited by the accounting firm of Darnall, Sikes & Frederick.
- 17. Each participant, donor, and/or purchaser acknowledges and agrees that MPCS is not liable for any lost, late, misdirected, undelivered, or destroyed entries regardless of the person responsible or cause, including without limitation any problem or technical malfunction of any computer or other electronic device, software, electronic platform, payment system, internet connection, connectivity network or server.
- 18. MPCS will not sell or provide access to your information to any third person.
- 19. The event is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
- 20. Louisiana charitable gaming permit: G0004181.
- 21. You agree that any and all disputes (a) related to playing the Game and/or participating in the raffle, (b) related to any of its Rules or Regulations, or (c) concerning the validity of this Arbitration clause, will be referred to and finally resolved by binding arbitration held in Lafayette, Louisiana before an arbitrator designated by Perry Dampf Dispute Solutions. Such arbitration will be conducted under rules to be determined by the designated arbitrator in his or her sole discretion. Any award rendered by the arbitrator will be final and binding upon each of the parties, and judgment of the award may be entered in any court having jurisdiction. Without limiting the applicability of the binding arbitration, any civil action related to the Game, the raffle, or this agreement may be brought exclusively in the State or Federal Courts located in Lafayette, Louisiana.
